Discount for yearly in advance payment: To be eligible for the discount, payment of the ANNUAL fees and levies must be made in full by the due date of the Term 1 Account Statement. Please deduct the discount of \$350 (for a single family), \$600 (two student family) or \$800 (three or more student family) from the 'Annual Total Compulsory Charges Due' to determine the payment amount. Annual fee payment can be made by Bpay or BPOINT (Visa or Mastercard link on the Parent Portal or BCE Connect App). An annual invoice cannot be issued by the Finance Office for upfront/annual payment.

Note – If applicable, please ensure to include items such as Opening Balance from 2024, Choir Levy, Ensemble Levy, Instrument Hire, Dance, Cocurricular Sport, Senior Online subjects and VET/Certificate Subjects. Year Level Levies include Camp, Retreat or Sleepover where applicable. These are Curriculum activities and therefore non-refundable. Where possible all regular charges to school fees have been included in this table. **Please note other additional charges may be invoiced to school fees, for example CPR/Snr First Aid Course, Music Camp, and Drama Club. Such charges will be communicated to parents by the activity coordinator.**

Use the Payment Calculator Link [Ready Reckoner](#) to calculate the 'Payment Amount' and 'End Date' (required fields are: *Total Annual Fee, Frequency, Number of Instalments and Start Date*). The 'End Date' calculation must be dated prior to **30 November 2025**. The authority must be received at the Finance Office at least five working days prior to the 'Start Date'.
